Mobile phones and technology policy -

At Lindfield Learning Village we prioritise the safety of every student and recognise the need for students to learn to self-regulate their use of technology throughout their day - not only at school.

The school recognises that many parents decide that their child can carry a mobile phone. If a student brings a phone to school they must ensure the mobile phone is TURNED OFF and put away (at all times) during school hours; between 8.20am and the end of the school day. This includes recess and lunch times. Exemptions for medical reasons or exceptional circumstances can be requested through a parent email attention to the Principal at <u>lindfieldlearningvillage@det.nsw.edu.au</u>. Please provide medical or other evidence for your request.

Authorised usage of electronic devices is permitted only under the direct instruction of teachers, including video and audio recording.

The school takes no responsibility for the security of mobile phones. They are brought to school at the owner's risk.

If parents need to contact students they are to phone the school on 9415 8006. Students must not use their phone to contact parents during school hours. In an emergency students can gain access to a phone by asking a member of staff.

The use of mobile phones at school can lead to problems such as:

- Security/theft
- o Harassment
- o Distraction in class
- o Social division
- o Cheating in exams

In accordance with NESA's policies, students may not have a mobile phone with them in any room where an HSC examination is being conducted.

Repeated failure to observe the regulations in relation to mobile phones will result in a discussion with the student to develop a Student Growth plan. Parents may also be contacted to request support to change in behaviour.

What can you do as a parent?

There are polarising opinions on whether mobile phones should be banned in schools. At LLV we prioritise teaching students to be responsible users of all forms of technology. We understand that technology, including mobile phones, offer incredible opportunities for learning but can also have the potential to be a negative influence.

We will work with students to support them to find a healthy balance in their use of technology which is appropriate to their age and stage of development. They will be taught digital literacy, allowing them to thrive in a technological world but will also be educated in digital citizenship and cybersafety.

If you have chosen to buy your child a phone for safety reasons but are concerned that they may be using it at school, there are a variety of Apps that you can use to limit their access. Here are some suggestions:

- · Parental Control/Family Time Includes a small cost
- · Family Link- Includes a small cost
- · Qustodio Includes a small cost
- · Screen Time Free (under settings on iPhones)

The school is very conscious about the use of various forms of social media by parents to have discussions about this and other topics related to the school. It is important that parents are aware of the potential for this form of communication, where opinions are shared but are not necessarily informed by the school, to cause unnecessary stress for both parents and staff.

Useful information:

- The Department of Education fire wall is extremely robust and restricts student access to many sites including YouTube. They cannot access any site which may be considered inappropriate whilst on the Department of Education wifi.
- Minecraft is a program that is used frequently in schools as it has great educational value across a variety of areas including Maths and Engineering. We have a number of teachers at school who are Minecraft experts. There are setting within Minecraft which restrict access to violent games.
